



What does the phrase, "fostering change," mean to you? Is change something you welcome? Or does the concept make you feel uncomfortable? Maybe a little of both? 2010 was a year of change for the Action Alliance as the governing body and staff worked to achieve our mission of a world where "ALL people have the right to a life free of violence."

"ALL people" means something different in today's Virginia than it did almost 30 years ago when the Action Alliance was established as a coalition of local victim service providers. According to the 2010 U.S. Census, between 2000 and 2010, there has been a 92% increase in the population of Hispanics/Latinos and a 72% increase in the population of Asians who live in Virginia. How do changes like this affect how we serve sexual and domestic violence victims--Virginia- or foreign-born, immigrant or American? Through the Action Alliance's Immigration Advocacy Technical Assistance Project, staff have been working to assess services, identify gaps and implement improvements. We strive to represent the diversity of those we serve.

As you probably know, the Action Alliance operates the statewide, 24-hour Virginia Family Violence and Sexual Assault Hotline, a lifesaver for many victims throughout Virginia. From October 2009 to September 2010, staff answered 28% more calls than they did the prior year in English, Spanish as well as other languages. We strive to serve victims--young, elderly, disabled, college students, women, men and their children--day and night.

As we work to address domestic and sexual violence, we strive to prevent it, too. Action Alliance prevention staff developed a "recipe card" and talking points to explain difficult concepts of promoting healthy relationships and diminishing perpetration in a user-friendly way. We expanded the Red Flag Campaign to all 80 college and university campuses in Virginia (not to mention the over 100 colleges and universities in 28 states that became affiliated with the Campaign by the end of 2010).

Action Alliance staff conducted trainings, technical assistance projects, the third annual Child Advocacy Conference, the seventh annual Women of Color Caucus Conference and the 2010 Annual Retreat. We updated the VAdata system, our web-based data collection system of local service providers. We made every effort to meet the needs of all who work in this field—from newcomers to seasoned professionals.

During 2010, we advocated for better protective order laws, in part, by convening a Protective Order Summit to explore our current system and identify areas for improvement. The Summit resulted in a comprehensive package of recommendations to the Virginia State Crime Commission. We strive to ensure that regardless of his/her relationship to the perpetrator, a victim of domestic violence, dating violence, stalking or sexual assault has equal access to protective orders.

Mohandas Gandhi (one of the leaders who helped free India from England's colonial rule) said, "Be the change you want to see in the world." When I look back on our 2010 accomplishments and the many others you will read about in this Annual Report, I cannot help but think that the Action Alliance IS the change we want to see in our world.


Our mission

Prevention Recipe Card and Talking Points

Primary prevention is about changing individuals, relationships, communities, and society through strategies that:

- 1) Promote factors associated with healthy relationships and healthy sexuality, and;
- 2) Counteract factors associated with the initial perpetration of sexual violence and intimate partner violence.

How to explain such complex concepts in a fun and simple way? We created a recipe card for prevention to help local programs do just that, along with supplemental "primary prevention talking points." The National Sexual Violence Resource Center was so impressed, they featured the Prevention Recipe Card on their website!

2010 Retreat: "Still I Rise"

The annual 3-day training/retreat in June, "Still I Rise", focused on self-care and trauma stewardship. The event drew 164 advocates from across the Commonwealth to sharpen their advocacy knowledge and skills, connect, network, and relax. This year's retreat welcomed keynote speaker Laura van Dernoot Lipsky. Laura spoke about her recently published book, "Trauma Stewardship," which provides insight on the impact trauma experienced by advocates in the course of their work and provides creative and innovative ways of addressing the issue.

serving the needs of people affected by violence

Immigration Advocacy Technical Assistance Project

2010 saw quite an expansion in the Action Alliance's Immigration Advocacy Technical Assistance Project, starting with conducting interviews with professionals across the state to identify gaps in service delivery and training needs. As a result of this needs

assessment, we offered the following training opportunities in 2010 for professionals working with immigrant survivors of domestic and sexual violence:

- A **statewide technical assistance call** for advocates, featuring the Tahirih Justice Center, a nationally-recognized non-profit working on human rights and international violence against women.
- A statewide multidisciplinary training for victim advocates, which included such topics as rights and barriers of immigrant survivors of domestic and sexual violence, immigration relief, public benefits for immigrant survivors-federal and state, and access to services for people with limited proficiency in English.
- A **networking event** for professionals to create realistic plans of action to prioritize and address identified gaps in services for immigrant survivors.

28% Increase in Calls Answered by Statewide Hotline

The Action Alliance operates the statewide, 24-hour Virginia Family Violence & Sexual Assault Hotline. From October 2009 through September 2010, the Virginia Family Violence and Sexual Assault Hotline responded to 4,185 crisis calls, 967 requests for technical assistance from community professionals and 37,343 calls for local Sexual & Domestic Violence Agencies during the time the Hotline was serving as back-up to 30 local agencies throughout Virginia. In the prior year, the Hotline backed up 25 agencies, and the 20% increase in the number of agencies had an impact of a 28% increase in call volume for the year.

providing intensive problem-solving and resources to advocates and allied professionals

Training Institute for Professionals Working on the Front Lines

Every year, the Action Alliance Training Institute provides basic advocacy, advanced advocacy, and program administration training for people working in Sexual and Domestic Violence Agencies. In 2010, we added a new Cultural Competency curriculum to our Basic Advocacy Training line-up, and held 30 single and multiple day events for 626 victim advocates and allied professionals.

Technical Assistance, Needs Assessment, and Comprehensive Planning

The Action Alliance provides technical assistance (TA) to local Sexual and Domestic Violence Agencies on an ongoing basis, responding to more than 70 requests for assistance each month, and providing on-site assistance as appropriate. In 2010, we coordinated 10 technical assistance calls during the year for Sexual and Domestic Violence Advocacy Members on such topics as: Public Policy, Prevention, VAdata, Trauma, Substance Abuse, and Immigration.

THE RED FLAG CAMPAIGN

Addressing dating violence on college campuses

In 2007, the Action Alliance created The Red Flag Campaign (with help from Verizon Foundation) to address dating violence on college campuses. The Red Flag Campaign is an innovative bystander intervention campaign designed to address and prevent dating violence among college students.

In 2010, we developed a new series of posters to broaden the racial and ethnic diversity of the models represented in the campaign posters as a result of helpful feedback from our partners at historically black colleges and universities. We also added a new (smaller) size poster to the Red Flag Campaign.

In response to the homicide of University of Virginia student Yeardley Love, allegedly at the hands of her ex-boyfriend, Verizon Foundation and Verizon Wireless decided to make social change by funding y The Red Flag Campaign to every college and university in Virginia (a total of 80 campuses)!

By the end of 2010, over 100 colleges and universities in 28 states nationwide had become affiliated with the Campaign.

The Action Alliance partnered with Verizon Foundation and Richmond public television to co-sponsor a Domestic Violence Awareness Month event in October. The event featured a reception and preview of "Telling Amy's Story" (a documentary about the homicide of a Verizon employee at the hands of her husband), followed by a taping of a panel discussion about Virginia's response to domestic violence. Both the panel discussion and the statewide broadcast of the "Telling Amy's Story" documentary on all PBS stations (except Northern Virginia) on October 7.

Protective Order Summit

This year, we worked with the Virginia Poverty Law Center to convene a Protective Order Summit to bring together a diverse group of professionals to explore what is working well and what needs to be improved for victims of domestic and sexual violence who are seeking protective orders. The group identified significant barriers for victims seeking protections and the need to improve access for all victims of domestic and sexual violence. Based on the Summit's work, the Action Alliance presented a package of recommendations to the State Crime Commission and members of the General Assembly to provide equal access to protective orders and equal protections to enforce them for victims of domestic violence, dating violence, stalking and sexual assault.


Women of Color Leadership Conference

enhancing coordinated community responses

Child Advocacy Annual Conference

In April, 2010, the Child Advocacy Task Force of the Action Alliance held its 3rd annual full-day conference entitled, "Trauma: Understanding Violence and Its Impact on Advocates". 55 professionals attended the conference, which included workshops focusing on vicarious trauma/compassion fatigue, self care, children exposed to trauma and the primary prevention of child sexual abuse.



VAdata: Virginia's Data Collection System for Sexual & Domestic Violence Agencies

The Action Alliance manages VAdata, a nationally recognized electronic web-based data collection system that tracks services provided by Virginia's Sexual and Domestic Violence Service Agencies. VAdata provides a summary of data on the adults and children served by these agencies, including a description of the violence experienced, the perpetrators of that violence, the impact of the violence and strategies used to cope with its effects, and the services received.

In 2010, we refreshed the look of the original VAdata website (launched way back in 1999!) by totally redesigning the website as well as all of the data entry forms. Sixty local Sexual and Domestic Violence Agencies and the Virginia Sexual Assault and Family Violence Hotline used VAdata regularly in 2010.

Accreditation Resource Notebook

The Action Alliance coordinates a peer-review certification process for community Sexual and Domestic Violence Agencies to ensure consistent and effective services throughout the state. Agencies are evaluated for policy and practice in a number of categories including hotline, emergency shelter, emergency transportation, crisis intervention, counseling and advocacy, systems advocacy, training, and community education. In 2010, we developed the new Accreditation Resource Notebook to help applicant agencies. The Accreditation Notebook offers helpful tools such as model policies, templates and information and resources related to the Accreditation Criteria.





Revolution: A journal for those working to stop sexual and domestic violence

In 2010, we published the 4th volume of "Revolution", our journal for professionals working on the front lines. The new edition of Revolution focuses on working with immigrant survivors of sexual and intimate partner violence, and is available in PDF format on our website.


